- b) Councillor Tucker reported that he and the Manager of Glastonbury Chamber of Commerce had attended the launch of the Regeneration Through Heritage Booklet. The Prince's Regeneration Trust produced the booklet to guide Community groups in the early stages of a project to regenerate redundant historic buildings. A copy of the booklet which features a case study on the Baily's buildings on the Morland's site and the formation of the Beckery Island Regeneration Partnership was lodged with the Town Clerk. The presentation of the Feasibility Report from Architecton would be held on 1st June 2006.
- c) Inspector Paul Richards announced a restructure of the local Police Force and asked for permission to make a future presentation. It was agreed that he should attend the June Council meeting.

The Glastonbury Town Council hereby instructs the Town Clerk to object in writing to any and all authorities which use, or attempt to use, the place name 'Glastonbury' in such a manner stating that the place name and the use of the place name 'Glastonbury' is the sole prerogative of the Town'.

It was **AGREED** that the matter should be put in the hands of the Property and Assets Committee, following legal advice regarding the Glastonbury Festivals Ltd attempt to trademark the town name.

9. LOCAL DEVELOPMENT FRAMEWORK
