30. TO RECEIVE APOLOGIES FOR ABSENCE AND NOTE REASONS GIVEN

37. TO DISCUSS WINTER BEDDING AND THE WINTER HANGING BASKETS FOR THE TOWN HALL

The Committee Clerk advised the committee that she had sent out for tender for Glastonbury Town Council winter bedding and only had received 1 quote back from which was from Sweet Acre Nursery. New for this year will be hanging winter baskets for the outside of the Town Hall, St Dunstan's Cottage and the toilet block in the St Dunstan's car park. The War Memorial will have poppies added to the existing rosemary within the floral display.

Cllr M White agreed to the tender from Sweet Acre Nursery to provide for the Glastonbury in Bloom 2024 winter bedding. This was seconded by Cllr M Oakden and **AGREED** unanimously.

38. TO DISCUSS THE PRESENTATION EVENING ON THE FRIDAY 25TH OCTOBER 2024

The Committee Clerk will send out invitations at the beginning of October to invite sponsors, business and community gardens, the residents that took part in the Glastonbury in Bloom competition. As well as the people that hep with Bloom behind the scenes, she added that the round tables may have to be changed to the trellis ones due to numbers, but we can make that decision nearer the time. Some of our sponsors are kindly helping us with the food Beckets Inn will be supplying the nibbles, Dowlas are happy to supply samples of gin and Burns the bread donating their Torsy Morsey cake.

39. TO RECEIVE AN UPDATE ON THE COMMUNITY PAYBACK SERVICE

The Committee Clerk reported that her main contact was back from sick leave and already in contact with her about areas within Glastonbury that need doing. She continued to report that she had made Chilkwell Street a priority and that the Community Pay Back came and did this area on Saturday.
