Councillors reviewed and discussed the documents received from the Tor Collective.

It was proposed by Cllr Roney-Dougal to agree to the proposal, with a six-month trial with some alterations including width of pavements and emergency routes, trading licenses and public liability is in place and proposed locations and dates.
