19. COMMUNITY POLICE OFFICER

Sergeant Halliwell reported the crime figures for Glastonbury beat since 1st April 2004 as 46, this is a decrease of 34 on the same period last year. He informed the Council of the Force website address – www.avonandsomerset.gov.uk.
